Code Of Ethics for Members

To be used in conduction with CCC (Qld) code of ethics.

Please Initial

I/We shall always ensure that any dog under my care and control is properly housed. Provide sufficient suitable food and drink, exercised and receives proper veterinary attention if required.

I/We should not allow and dog under my care to roan at large and when on public display or away from my home, ensure that they are kept fully leashed, always crated or under effective control.

I/We should breed only for the purpose of improving the standard and not for other commercial purpose.

I/We should not knowingly permit any of my purebred dogs to be mated to a dog of a different breed, to a crossbred dog or any other dog of the same breed not registered with Dogs Australia.

I/We should not sell of otherwise transfer from my care any puppy under (8) weeks of age, thus allowing for vaccinations to be given, and the necessary time for the vaccine to take effect.

I/We should ensure that all persons acquiring dogs from me/us clearly understand their responsibility for the care and welfare of the animal, and that they have the time, facilities (ie. Adequate fencing, sufficient room and proper shelter etc.) to perform their obligations.

I/We should provide all purchaser of dogs placed by me written details of all dietary and immunisation requirements and/or an appropriate publication relating to such requirements and responsible dog ownership.

I/We shall not knowingly sell a dog to commercial dog wholesalers, retail pet dealers, or directly or indirectly allow a dog to be given as a prize or donation in any contest of any kind.
